

WRESTLING COACH POSTSEASON MEETING AGENDA

- 1. Collection of sportsmanship ballots.** I have received ballots from Maria Carrillo (boys' and girls'), Rancho Cotate (boys' and girls') and Windsor (boys'). Everyone else needs to either email me the ballot(s) or bring them to the meeting. I have attached another copy for your convenience. **Windsor and Casa say they emailed. Collected: Montgomery (boys), Ukiah (boys & Girls), Santa Rosa (boys & Girls), Newman showed up late and did not turn one in.**
- 2. All-league selections.** Generally, in individual sports, we have based this list on finishers at the NBL Championships. First place finishers are first team all-leaguers, second place finishers are second team all-leaguers and third place finishers are honorable mention.
Motion: Finisher of NBL league and NBL league tournament as a starting point for selecting 1st, 2nd, and honorable mention all-league wrestlers. Coaches are allowed to nominate additional wrestlers for all league based on state, section, league performance in that order for coaches majority vote. Pass 7 - 0
Rational: There are times when a NBL wrestler will outperform the league champion at the state, section or League tournament level. Coaches would like the opportunity to nominate that wrestler for 1st, 2nd, or honorable mention all-league.\

- 3. Election of NBL reps to the NCS wrestling management committee.** The bylaw relating to this election is italicized below. Thank you to Tim Bruce and Shane Robertson, who have both completed their term of office. You both did a wonderful job representing the NBL and sharing NCS information with the league coaches. Your efforts are sincerely appreciated. This year we had a tie for first place in the NBL, which meant that a decision had to be made to determine who would represent the NBL along with Tim--Rich or Thomas. The tie-breaker that was used was the winter draw by principals. The athletic directors did not like this method of breaking the tie (leaves it to chance) and proposed that the tie-breaker be head-to-head competition during the dual meet schedule. Is there any other proposal that you would like to put forth to the principals regarding this situation?

The position of NBL representative to the North Coast Section shall be voted on by the North Bay League varsity wrestling coaches and will be a two-year term. The league representative will represent the North Bay League in a fair and equitable manner at required functions, to include the fall and spring Wrestling Management Committee meetings and the North Coast Section Wrestling Championships Seeding Meeting. If this position is vacated during the two-year term, a new election will be held.

The NBL wrestling representative and a representative from the first place team will attend the NCS Seeding Meeting. If a representative from the first place team is the elected league representative or if the representative from the first place team cannot attend for any reason, then a representative from the second place team shall attend the NCS seeding meeting. If the second place team cannot send a representative, then a representative from the third place team shall go, and so on, to ensure that there will be two representatives in attendance at the NCS Championships Seeding Committee Meeting.

The league representative is required to represent the entire league and all league wrestlers, regardless of school affiliation. The representative is to put the best interest of the league and student-athletes ahead of the interest of the representative's team. NBL Board of Managers, 4/22/2014

Tabled: Bylaw 14.805.2, adding additional language...The coaches, by majority vote, **which will not be unreasonably withheld**, will determine whether or not to allow participation at the NCS Championships through the at-large process.
